The Procedure at a Glance

Debt Collection

This is what you should do:

- Should your customer fail to pay an invoice, send him a commercial reminder setting a deadline.
- Should your costumer still fail to pay, award a Collection Order to Euler Hermes either per form sheet or online – as a credit insurance customer please do this by the point in time agreed upon in the contract at the latest. Should you already possess a titled claim, send this to us.

Important: please notify us close to the event, should the debtor have in the meantime contacted you or effected a payment to you.

What we do for you:

- You receive from us at first an Order Confirmation.
- We review the eligibility of your claim for collection and send the debtor a written demand for payment.
- A short time after that we call the debtor and negotiate with him – friendly in our manner, but resolute with regards to the case. Where it makes sense to do so, we will also visit him at his premises.
- Should the debtor still fail to pay, we shall initiate a legal default action on your behalf.
- Should the debtor contest this action, we will find experienced lawyers for you who will act on your behalf.
- Should you, following a successful action, have indeed gained a title but your customer is insolvent, we will monitor him for a period of up to 30 years. We will thereby continue to serve the debtor with reminders at reasonable intervals and exploit all possibilities of compulsory enforcement.

Should your debtor pay, we will immediately settle the collection proceeds in accordance with our General Terms and Conditions. As a collection agency we are as a fundamental principle not subject to any scale of charges.

The invoice for the collection costs shall be issued analogous to the Act on the Remuneration for Lawyers (VV 2300 BVG).
